This position is responsible for cleaning and maintaining the lab areas of the Braman Family Education Center Building, as directed by the Industrial Technology Lab Coordinator or the Industrial Technologies Department Chair.

The duties may include cleaning, minor maintenance and repairs on machinery and equipment in the Robotics, Welding, CNC, Electrical, and Machine shop. Other duties may be assigned.
