The Trustees reviewed minutes from their August 12, 2025, regular meeting. Mr. Peterson said the minutes stand approved as read.

The Trustees reviewed financial reports. Mr. Peterson said the financial report stands approved as presented.

The Howard City community leaders introduced themselves and discussed with the Trustees their area interests and initiatives.

Howard City Village Manager Mike Falcon thanked the board for coming to Howard City. He talked about growth in area, new businesses, renovation of the train depot into a community space, and paving of the White Pine Trail. He asked if there are future opportunities to bring MCC classes back to the Howard City area.

Montcalm Economic Alliance Executive Director complimented MCC as being one of the organization's vision partners and talked about initiatives she is focusing on.

Tri County Area Schools Superintendent Ryan Biller provided an update about upgrades being made to the stadium facility as well as the new elementary school that was constructed three years ago. He said these projects are creating opportunities for students. He also said he appreciates the partnership with MCC in bringing dual enrollment to the Tri County school district. A current initiative is an attempt to build out an alternative education program.

Dean for Student and Enrollment Services Francisco Ramirez introduced MCC nursing student Kimberly Murphy, who shared her story as the student leader of the nursing cohort. Ms. Murphy departed the meeting at 6:32 p.m.

Shannon Neumann-Kilduff and Jamie Hansen-Hopkins provided a 2025 Montcalm Heritage Festival report. They departed the meeting at 6:25 p.m.

Shannon Tripp and Charlotte Greene provided an Early College update. Mrs. Tripp reported that during the 13 years of the program, students have earned 185 associate degrees, eight one-year certificates and 18 other program certificates. Ms. Greene talked about her experience as an Early College student and how it has helped her both academically and professionally.

Dr. Barrick shared his president's report, including an enrollment update and the submission of former Board Chairperson Karen Carbonelli for recognition during the "In Memory" presentation at the upcoming ACCT Conference.

Dr. Barrick expressed his appreciation for having community members in attendance and thanked them for sharing their comments with the Board. Guests were invited to stay for the remainder of the meeting or given the opportunity to leave. Mr. Biller, Mr. Falcon, Ms. Neff, Ms. Greene and Mrs. Tripp departed the meeting at 6:42 p.m.

The Trustees briefly reviewed the draft Community College Local Strategic Value for state appropriations under Section 230(2) of the State School Aid Act (MCL.338.1830), with Vice President Wagenmaker providing a brief overview of the report.

Chairman Kurt Peterson reappointed Joyce Kitchenmaster to the Audit Committee, with her term expiring Oct. 11, 2028.
